# Hon. Hugh L. Fraser, O.C., FCIArb, FCCA

The Honourable Hugh L. Fraser is a retired Judge with nearly three decades of experience as a Justice in the Ontario Court of Justice. Prior to his appointment to the bench, Justice Fraser worked as a lawyer in private practice and served on the Canadian Human Rights Tribunal for seven years. As a former Olympian, Justice Fraser took particular interest in sports law, holding a place on the Court of Arbitration for Sport since 1995 and served on the first ad hoc Court at the Olympic Games in 1996.

Justice Fraser currently serves as an independent Arbitrator with the United States Olympics and Paralympic Committee (USOPC), the USOPC Athletes' Advisory Council, the United States Anti-Doping Agency and is a Commissioner with Athletics Canada as well as one of 15 adjudicators on the NCAA Independent Resolution Panel for Complex Cases.

Outside of the legal space, Justice Fraser is a former Olympian and a recognized international expert in sports law. He has held several administrative positions in sport including President of the Sports Federation of Canada, President of the Commonwealth Games Foundation of Canada, and on the board of the Canadian Centre for Ethics in Sport.

On December 29, 2021, Justice Fraser was appointed as Officer of the Order of Canada for his contribution to Canadian sport.

He was born in Kingston, Jamaica, grew up in Kingston, Ontario and currently resides in Ottawa, Ontario.

## **Grant Borbridge**

Grant Borbridge is an experienced executive who is currently Vice President, Legal and Corporate Secretary at Trimac Transportation where he oversees Trimac's governance and corporate structures, and its legal, environmental compliance, risk management and ESG reporting departments across Canada and the United States. # **Cassie Campbell-Pascall**

Cassie Campbell-Pascall is a three-time Olympic champion, an eight-time world champion and the only captain to lead Team Canada to two Olympic gold medals. Campbell was also the first

female hockey player inducted into Canada's Sports Hall of Fame and is an Order of Canada recipient. Campbell made strides as the first woman to provide colour commentary on Hockey Night in Canada and has continued her career as a sports broadcaster for both Sportsnet and ESPN.

As a long-time advocate for professional women's hockey, Campbell is actively involved in the community. She established the Scotiabank Girls Hockey Fest and the Chevrolet Safe and Fun Hockey Program. For 12 years, Campbell ran the Annual Cassie Campbell Street Hockey Festival in Calgary in support of Ronald McDonald House Southern Alberta which raised \$3.5 million.

Campbell currently sits on the Hockey Canada Foundation Board. She has extensive board experience, having previously served as a board member of the Calgary Olympic Development Association, Canada's Sports Hall of Fame and the Calgary Police Foundation Board. She was formerly a Canadian Olympic Committee Executive Member of the Athlete Council.

Campbell was born in Richmond Hill, Ontario and currently resides in Calgary, Alberta.

## Julie Duranceau

Julie Duranceau is an experienced lawyer and an accredited mediator in civil, commercial, labour and family matters. Duranceau began her career as a civil and commercial litigator at law firm Stikeman Elliott. Marian Jacko, Anishinaabe from Wiikwemkoong First Nation, is the Assistant Deputy Attorney General for the Indigenous Justice Division of the Ontario Ministry of the Attorney General. Prior to this role, she was appointed by Order-in-council as The Children's Lawyer for Ontario. Marian has made significant contributions to the legal profession including being the first Indigenous person appointed as The Children's Lawyer for Ontario, where she spent nearly 20 years representing and advocating for the personal and property rights of children and youth. Marian has spent her entire 24-year legal career tirelessly working on behalf of children and Indigenous peoples.

Marian raised her eldest child as a single parent while earning three University degrees, including a Master's degree in Social Work and a law degree from the University of Toronto. While working full-time as a lawyer and raising three children, Marian obtained her Master of Law degree from York University in 2005.

Marian strongly believes in community service, serving on many non-profit organizations' boards and advisory committees over the years. Currently, Marian is the President of the Little Native Hockey League ("Little NHL") and President of Anishnawbe Health of Toronto. She also joins a volunteer Board of Mentors with the Future of Hockey Lab whose work is committed to values-based social innovation and culture change while growing the game of ice hockey.

Marian has over a decade of coaching experience having coached at the Little NHL over many years, at the National Aboriginal Hockey Championships and the Ontario Summer Games. She is currently the head coach of the U18A team in North York. Marian is passionate about the sport of ice hockey and believes it has the potential to change the narrative for Indigenous children and youth to one of resilience.
