

The BNQ certification mark/logo, the mention "BALLISTIC NYLON BALLISTIQUE", the model identification "TCPRE SR" or "TCPRE JR", the sizing information in lettered reference, and metric and imperial measurements are also screen printed in white.

The products are further identified by the following identifier code: 99X-YYK-TCPRE-BLK, where 9 can represent any number and X can represent any letter. This code is located on the inside label of each neck protector.

Hazard identified

The throat protectors have been decertified by Bureau de normalisation du Québec (BNQ) for non-conformance to certification requirements. This could pose a risk of throat laceration should a skate come in contact with the throat protector.

Neither Health Canada nor Sports Maska Inc. has received any reports of consumer incidents or injuries to Canadians related to the use of this throat protector.
