

## **CONTEST RULES & REGULATIONS**

### **Hockey Canada World Junior Championship "Ontario Skills Challenge"**

Hockey Canada World Junior Championship "Ontario Skills Challenge" Contest (the "Contest") is brought to you by Hockey Canada (the "Contest Sponsors").

1. The Contest starts at 12:01am on Monday, November 24, 2014 and continues until 11:59pm on Tuesday, December 23, 2014 (the "Contest Period"). All times are Eastern Standard Time. No purchase necessary. Only one (1) entry per Minor Hockey team during the Contest Period is allowed.

2. How the "Ontario Skills Challenge" works:

i. Step 1 - Coaches of Minor Hockey teams in Ontario will conduct their own Hockey Canada National Skills Standards Testing Program. Download and print the Hockey Canada On-Ice team record sheets found on the <http://www.hockeycanada.ca/en-ca/Hockey-Programs/Players/Skills-Testing/Test-Procedures> website. Coaches - put your players through the Hockey Canada National Skills Standards Testing program and record results on the recording sheets provided.

ii. Step 2 - After completing the Skills Challenge - email your Skills Challenge On-Ice Record sheet with your team info: player names and, of course, your skills challenge results to Hockey Canada at [wjcskills@hockeycanada.ca](mailto:wjcskills@hockeycanada.ca).

From all entries received - Hockey Canada will conduct a random draw to determine the Potential Prize Winner.

3. From all eligible entries received, a random draw will be completed by a representative of Hockey Canada. The random draw will be made at approximately 10:00am at the offices of Hockey Canada, 400 Kipling Ave, Toronto, ON M8V 3L1 on Friday, December 26, 2014.

4. If the Potential Grand Prize Winner cannot be reached within two (2) business days following the draw, or declines the Grand Prize, or otherwise fails to comply with any portion of these Contest rules, another entrant will be selected to be the Potential Grand Prize Winner using the process generally described in paragraphs 3 and 4 of these Rules.

5. Grand Prize:

There is one (1) Grand Prize (the "Grand Prize") available to be won from all valid entries received during the Contest Period. The Grand Prize will consist of forty (40) tickets to the 2015 World Junior Championship December 30<sup>th</sup>, 2014 5:00 PM EST Switzerland vs. Denmark Game at the Air Canada Centre in Toronto, ON. Approximate value of the Grand Prize is: \$500 CDN. Potential winners are solely responsible for all other fees and charges not specifically mentioned as part of the Grand Prize.

6. Prizes must be accepted as awarded and may not be transferred, exchanged or redeemed for cash, except at the sole discretion of the Contest Sponsors. Any unused portion of the Grand Prize will be forfeited and have no cash value. Winners are not entitled to any monetary difference between the actual Grand Prize value and the stated approximate Grand Prize value, if any. Contest Sponsors reserve the right to substitute a prize of greater or equal value in the event of the unavailability, for whatever reason, of the advertised Grand Prize. Contest Sponsors shall not assume any liability for lost, damaged or misdirected prizes.

7. By entering this contest, entrants consent to the use of their entry, name, city of residence and/or any photograph of or that may be taken in publicity carried out by Hockey Canada and/or its advertising agencies, without further notice or compensation.

8. This contest is open to residents of Ontario who are over the age of majority, excluding employees of the Contest Sponsors, their parent and affiliated companies, representatives, dealers and agents, contest suppliers and judges, and those with whom they are domiciled. The contest is subject to all applicable federal, provincial and municipal laws and regulations.

9. No communications will be entered into except with selected entrants.

10. Odds of winning depend on the number of eligible entries received. All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of the rules may be disqualified by Hockey Canada. Hockey Canada takes no responsibility for lost, stolen, delayed, damaged, misdirected, late or destroyed entries, or for typographical or other production errors. Hockey Canada is not responsible for any errors or omissions in printing or advertising this contest. All entries become the property of Hockey Canada and will not be returned.

12. By entering this contest, entrants release and hold harmless the Contest Sponsors, the International Ice Hockey Federation, their advertising and promotional agencies and the Contest judges, their respective parent companies, subsidiaries, affiliates and/or related companies and each of their employees, directors, officers, suppliers, agents, sponsors, administrators, licensees, representatives, advertising, media buying and promotional agencies (collectively the "Releasees") from any and all liability in connection with this Contest or, if declared a winner, the Grand Prize, for any injuries, loss or damage of any kind to the entrants or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of the Grand Prize, participation in the Contest, any breach of the Contest Rules, or in any prize-related activity. The entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the Contest, without limitation. By accepting the Grand Prize, the winner consents to the use of their name, place of residence, voice, statements, photographs or other likenesses for publicity, advertising or information purposes in any medium or format without further compensation or notice in perpetuity.

13. This contest will be run in accordance with these rules, subject to amendment by Hockey Canada. Contestants must comply with these rules, and will be deemed to have received and understood the rules by participating in the Contest. The terms of this Contest, as set out in these rules, are not subject to amendment or counter-offer, except as set out herein.

Hockey Canada assumes no responsibility or liability for failure of the internet, its electronic mail system, or its website during the Contest Period, for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, access providers, computer equipment, software, failure of any email or traffic congestion on the internet or at any website, or any combination thereof including any injury or damage to an entrant's or any other person's computer related to or resulting from playing or downloading any material in the Contest. Hockey Canada reserves the right, in its sole discretion, to cancel or suspend this Contest should a virus, bug or other cause beyond their reasonable control corrupt the security, fairness, integrity or proper administration of the Contest. Any attempt to deliberately damage any web site or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws. Should such an attempt be made, Hockey Canada reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution. In the event of cancellation, Hockey Canada may, in its sole discretion, elect to identify a Potential Prize Winner and award the Grand Prize by way of random drawing from among all non-suspect, eligible entries as determined by Hockey Canada in its absolute discretion, received up to the time of such cancellation.

15. If the identity of an entrant is disputed, the authorized account holder of the e-mail address submitted at the time of entry will be deemed to be the entrant. The individual assigned to the e-mail address for the domain associated with the submitted e-mail address is considered the authorized account holder.
